Hello, and thank you for supporting my little art shop! If you have purchased an Artwork Bundle from me, you will have received access to a number of documents: A PDF titled *Artwork Bundle Permissions*, a PDF titled *Artwork Commission Contract*, and PNGs for the artwork contained in the bundle. The PDF titled *Artwork Bundle Permissions* - the document you are reading right now - will explain what my Artwork Bundles are and the terms and conditions of their use as a customer who has purchased an Artwork Bundle. The PDF titled *Artwork Commission Contract* is the Contract which applies to all of my artwork goods or services. This is stated clearly on my [Shop Policies](#) page and is simply in place to protect my rights as the Artist. In the event that you lose access to these files, you can always find them on my [Services](#) page.

My office hours are **Monday - Thursday, 10 AM - 6 PM CST**, excluding US federal holidays and Wiccan sabbats. I try to respond to all communications within 24 office hours of receiving them, though responses may be slightly delayed during busier periods. Currently, this email is the best way to contact me, not social media.

About my Artwork Bundles

Artwork Bundles are collections of premade artwork and design materials which may include things such as clip art, emotes, branding kits, and more. With purchase, you receive access to download all material which was outlined within the listing of the Artwork Bundle. Pricing on Artwork Bundles is flat rate, runs at a generously discounted rate compared to custom commissioned pieces, and is delivered digitally only. Note that this ownership is not exclusive, as anyone may purchase the same Artwork Bundle you have.

Once purchased, you may use the materials contained within the Artwork Bundle for personal use only as outlined in the next section titled 'Customer Usage Permissions'.

Customer Usage Permissions

My Rights: Under United States copyright law, copyright protections begin the moment a work is fixed in a tangible media of expression. This means that when a piece of visual artwork is created visually - either by digital or physical medium - the artist who created the artwork has exclusive copyright for said piece. In possessing that exclusive copyright, the artist retains the sole and exclusive right to display, distribute, reproduce, and create derivative works based on that piece however they see fit.

I, as the Artist, will always retain these rights to the work I create unless otherwise discussed and put into a signed contract stating the contrary. Much - if not all - of the artwork that I create will be displayed on my website galleries and social media platforms at the moment I decide to display them and for as long as I decide to display them.

In the case of Artwork Bundles, this means that the artwork I create for my listings will be displayed publicly on my websites, on social media, or on any platform I may use in the sharing of my work. This includes the use of the continued sale of my Artwork Bundles for as long as I see fit.

Your Rights: In purchasing an Artwork Bundle from my shop, I grant you permission to display your finished piece(s) for personal use only (i.e. social media avatars, non-profit social media posts, personal home décor, etc.) - that is, in any way that does not have the potential to benefit you financially. When sharing my work, please note that you are not permitted to alter my work in any way, including the removal of any signatures I may place on my work. Finally, when sharing my work publicly, it is greatly appreciated but not required that

you credit me with my name (Dezy Delaceur or Dezydration) and a link to my website (Dezydration.com). Should you have any questions about these permissions, feel free to contact me.

As Artwork Bundles will tend to be used for branding or embellishment, I recognize that the line between what would be considered personal use and commercial use may be fuzzy. Here are some common use cases for my Artwork Bundles that I would consider to fall under personal use, as well as some commercial exceptions* I would allow exclusively in the case of my Artwork Bundles:

- Non-logo branding for websites or social media designs. I.e. your social media header, your social media profile picture, your website's header, embellishment imagery on your website or blog.
- Embellishment imagery for digital and physical marketing materials*.
- Emotes on your livestream chat or Discord server.

My Artwork Bundles may not be used for the following commercial uses:

- Logos or anything else you intend to intimately and exclusively associate with your brand.
- Within materials for resale, such as digital downloads, coloring books, sticker sheets, sticker bundles, etc. My Artwork Bundles may not be redistributed in any form whatsoever.
- For the training of image or prompt generation for AI/LLM models.

Note that these are not extensive lists of the things my Artwork Bundles may and may not be used for. If you are uncertain about any use case you have in mind, please contact me for confirmation.

On Commercial Licensing

In some cases (but not all), I am willing to offer a Commercial License for an Artwork Bundles (or an individual piece within a bundle) upon request.
